NO CLAIMS WILL BE ALLOWED UNLESS MADE WITHIN 10 DAYS OF RECEIPT OF GOODS.

Customers who opt to provide their own shipment insurance on our shipped goods are fully responsible for any damages or losses incurred on the goods after they leave our premises.

The above named credit applicant agrees that title to shipped & invoiced goods remains with the seller (Silverwolf) until such time as the purchaser (above named business) has fully discharged all debt incurred to the seller.
